## Service Offerings for Ensuring Access to School Communities

Youth Healthcare Alliance is a statewide nonprofit, advocacy, and membership association for school-based clinics. Below is a list of consultation and facilitation services made available by Youth Healthcare Alliance for communities starting, reorganizing, or enhancing school-based clinics both on-site and through telehealth extension. The contract timeline cannot exceed 12 months for each service level.

### BASIC LEVEL \$5,000

- Includes 40 hours of Youth Healthcare Alliance consultation on planning for new school-based clinics or school-based clinic-like service on as-needed basis. The consultation is conducted by video, phone, and/or email; in-person visits might involve additional travel costs.

### MID-LEVEL \$15,000

- Assigned Youth Healthcare Alliance consultant to assist local project coordinator for developing up to two components of the school-based clinic planning process (up to 140 hours not including travel time):
  - Parent, student, school, and community engagement
  - Needs assessment or market analysis
  - Operating plan, including facility layout and/or planning telehealth operations
  - Marketing and communications plan
  - Data collection and evaluation
  - Development of essential policies, procedures, and forms
  - Support, preparation, and/delivery of presentations to groups (e.g., boards, community groups)
  - Communications on engaging community and addressing concerns or issues
- Includes up to three in-person visits (up to 20 hours travel time) by Youth Healthcare Alliance consultant for key meetings

### FULL-SERVICE LEVEL \$25,000

- Assigned Youth Healthcare Alliance consultant to lead and/or facilitate strategic planning meetings of school-based clinic's community advisory council or other related committee. Includes up to six virtual visits (in-person with up to 40 hours travel time) by Youth Healthcare Alliance consultant for key meetings.

- Youth Healthcare Alliance consultant to lead or assist in the development of three components of the planning process (up to 200 hours not including travel time):
  - Parent, student, school, and community engagement
  - Needs assessment or market analysis
  - Operating plan, including facility layout and/or planning telehealth operations
  - Marketing and communications plan
  - Data collection and evaluation
  - Development of essential policies, procedures, and forms
  - Support, preparation, and/delivery of presentations to groups (e.g., boards, community groups)
  - Communications on engaging community and addressing concerns or issues

## OTHER CONSULTING OPTIONS

Depending on the model that your school community wishes to take on, Youth Healthcare Alliance can offer the following technical assistance supports:

- Exploring and building telehealth extensions (such as to add a service to current school-based clinic offerings, increase reach to current patients, enhance support for school nurses, and/or establish a hub and spoke model of care)
  - Research and presentation of telehealth use by school-based clinics
  - Technical assistance on start-up of telehealth extension including sample workflows, technology considerations, and staffing models
  - Needs and readiness assessments to determine expansion involving new schools to be served by the model
  - Support, preparation, and/delivery of presentations to groups (e.g., boards, community groups)
  - Communications on engaging community and addressing concerns or issues
- Exploring and building new school-linked models
  - Research and presentation on most up-to-date case studies and best practices for school-linked models
  - Needs assessment or market analysis to determine best suited delivery of care model
  - Strategic plan
  - Data collection and evaluation
  - Parent, student, school, and community engagement
  - Support, preparation, and/delivery of presentations to groups (e.g., boards, community groups)
  - Communications on engaging community and addressing concerns or issues
- Technical assistance on
  - Strengthening school and school-based clinic relationships
  - Strengthening clinical service integration (primary care, behavioral health, oral health)
  - Communications on engaging community and addressing concerns or issues
- Trainings or technical assistance on topics for your clinic staff, board of directors, or partner organizations to help advance your work:
  - Health equity
  - Operationalizing new clinical integrations
  - Healing-centered engagement
  - Other topics based on school-based clinic interest and Youth Healthcare Alliance staff expertise
